1. The Guyana Marketing Corporation invites sealed bids from eligible and qualified bidders for the Supply and Installation Services of a Complete Vertical Form, Fill and Seal packaging Line (VFFS) with Printer for the Agro-Processing Demonstration facility, Region No.3.
2. Bidding will be conducted through the National Competitive Bidding (NCB) procedures, specified in the Procurement Act 2003.
3. Qualification requirements include:
  - a) Experience as a supplier in carrying out of supply and installation services of this nature for the last 3 (three) years;
  - b) Valid NIS, VAT, TIN and GRA Compliance Certificates.

9. Successful bidder will be selected on the lowest evaluated bid with price format as described in respective bidding document.
